

## Method




**We analysed the implementation of 2201 grant agreements concluded by RSF in 2017 and checked with other research funding agencies in Russia for duplication in funding.**

**The results were compared to the similar studies conducted in 2015, 2016 and 2017.**

## Grant Agreements Monitoring

**956 grants (43%) had no problems identified, which is better than 2015 results (35%)**



## Grant Agreements Monitoring



**2099 violations of the essential terms of 1245 grant agreements**

**46 cases of manipulations when research funds were used for non-research purposes**

**Based on the assessment of grant reports, in 2015-2019 RSF suspended funding of 48 projects, 382 projects received warnings from the RSF Expert Council**

## On-Site Audits




Common Issues	%

**In 2018, RSF completed 49 on-site audits to check 104 projects**

**In 2018, RSF checked 9764 publications reported by RSF grantees in 2017**

**19% of them did not meet quality conditions**

## Duplicate Funding

**RSF rule: no third party funding of the same work is allowed.**

**As a results of cross-checking and screening applications with other research funders, in 2018 RSF identified 45 suspicious pairs of duplicate funding.**

**After manual investigation, one project was closed and 12 projects received warnings.**

**This calls for funding agencies in Russia and abroad to take further steps to nip duplicate awards.**

## Ethics in Review



**Ethics in review is another concern for the RSF with 1000 honorary foreign reviewers complementing 4000+ Russian reviewers.**

**Annually dozens of reviewers found violating the review guidelines, get expelled from the reviewers pool and banned for new review assignments.**

**In 2018, RSF implemented AI-enabled reviewer assignment solution but Col remains the potential issue.**

**Confidentiality issues:**

- **“Hello! I’ve got your proposal for review!”**
- **The winners are known before official public announcements**

## Conclusions

- 1. Lack of information of research misconduct and fraud in Russia, which may be on rise in recent years due to increased competition for research funds.**
- 2. RSF builds a nation-wide infrastructure to ensure research funds are used ethically. This involves webinars, audit visits and routine training work with grant recipients and peer-reviewers as well as the regular monitoring of grant agreements implementation.**
- 3. Integrity issues call for funding agencies in Russia and abroad to take further steps to nip duplicate awards.**
